

### **Classroom Champions Program**

Targeting grades Kindergarten through 8, Classroom Champions brings Olympians, Paralympians and Olympic/Paralympic games hopefuls (Athlete Mentors) into the classroom using videos and live chats. A kind of 21st century pen-pal, each athlete mentor adopts 3-10 classrooms per year. Focusing on their own personal journey, athletes teach about the hard work of training, goal setting, competition and perseverance.

# Junior ATB Program - planned to start in October

Budget inquiry - will know final student count at end of September which will determine budget numbers. Will have more information at next PC meeting. So far we are down 22 students. Division in general is down about 100 students.

We currently have 4 EAs funded from student services and 2 EAs that were budgeted for reading intervention etc.

Concern brought forward about pre-screen assessment for Kindergarten, and that there was no meet and greet for new families coming into Kindergarten etc. Positive feedback about screening but for new families coming in etc. there was no opportunity to come and see classroom and meet teacher. Danielle noted.

Superintendent opened the table for feedback on late school start up this year due to construction issues. Parent feedback seemed to be concerns about general lack up consistent reporting. A link to more information could be provided for more information if parent wants to have more information. Parents have some skepticism about transparency on details because of past experience. Superintendents first day of work was Aug 1st, 2015. Reports are provided as of noon today for air quality on the WRSD website. Samples found to be acceptable. Service Master is the company that found asbestos and is the abatement company but they are monitored by an outside company (APSR) for air quality verification.

To make up for the lost week, we are still above the hours we need for instruction which is 950 hour minimum. We were already above 950 hours before the week delay so we are still okay. Requested again to have updated information provided at minimum on WRSD website. Estimated time frame for gym completion is mid October. General frustration about lack of communication or the way information is provided to parents about what's happening. Consensus was that we'd rather have too much information than not enough. Whenever school is closed for even a day, it has to reported to Minister of Education.

#### Lochearn School Closure Update

Posted on September 3rd, 2015



Construction on the Lochearn Roof and flood damaged areas is moving along as estimated. The asbestos removal work in the gymnasium is on track to be completed by Thursday, September 3. Staff will be entering the building on Friday, September 4 to prepare for classes on Tuesday, September 8. Throughout the asbestos removal process, ongoing air quality in and out of the gymnasium was monitored for the presence of asbestos. Not once during the removal process was contamination outside of the gymnasium found. These reports will be provided to the public once we receive them from the third party indoor environmental consultant. The gymnasium is on schedule to be completed by the middle of October.

"The closure of our gym will affect us but we do have plans in place to ensure our students still have the daily required minutes for physical activity," stated Principal, Danielle Spencer. "Students will all be skating twice a week, moving regularly scheduled activities outside and in case of bad weather an extra classroom has been reconfigured for physical activity." The roofing area to the south of the front entrance is on schedule to be finished by the end of this week and the interior work will be finished before September 8. The next step in roof construction will be on the remaining south & south west area. Weather permitting, this area will be done by the end of September. Metal cladding is starting today on site which will put the final touches on the parapet caps and final flashing details. Following that installation, the eavestroughing / downspouts will be completed.
